Finance Achievements

Accurate collateral management enabled the bank to save millions in potential fines and maintained a satisfied customer base.

- Analyzed weekly more than 500 stocks, culling them down to 5-10 investment prospects. When active had 35+ investable stocks. Typically earn 20-50% annually on personal portfolio when active in the market.
- Uncovered double billing and other inappropriate invoicing saving over \$5 million in one year for one large manufacturer, while approving invoices as large as \$250,000.
- Managed \$5 million investment portfolio and an additional \$10 million in client assets and net worth. Clients and investors typically achieve approximately 20% return on their investments.

Proposal Achievements

- Proposed managing the nationwide asset disposition for Bank One (\$15+ million/yr) in a 100+ page document specifying six primary warehouse sites, 14 satellite sites, service levels and responsiveness criteria, asset removal methods, a disaster recovery plan, a customer survey process, EDI/EFT capabilities, key categories of remarketable/scrap equipment, an EPA certificate, an much more. Results - local program recycling tons of white paper, cardboard, aluminum, plastic and wire; 100+ computers to local community groups, Brazil school and missionaries; enhanced feeling of community service among employees. - Proposed, implemented and managed a residential treatment program funded by an \$80,000 federal LEAA grant. Wrote COWIC grant which started STNA training program for RICH.
- ◆ Proposed transforming the WTEF (Waste to Energy Facility in Columbus, OH) into a recycling center. Also proposed a \$35/mo trash collection fee that would pay for trash collection, enable free recycling and eliminate the city debt on the power plant within five years. (1999)
- Made two proposals to develop plastic reclaim facilities. Recycling all the plastic in Columbus could keep three \$25 million/yr reclaim facilities busy. In 1995, offered to buy the Quatuum Chemicals reclaim plant in Heath for \$6-12 million. In 1996 proposed a \$7 million reclaim facility in Mt Sterling designed to generate \$25 million/yr revenues.
- Made two proposals for other facilities. In 1978 proposed a HUD financed 100 bed \$3.5 million elderly housing project, jointly with Galbreath Mortgage, Forest City Dillion, and The Ohio Department of Mental Health. Two projects funded. We were 5th/30 proposals. In 1979 proposed purchase of Westerville Convalescent Center for \$1.5 million through a MRDD purchase of service contract. The project was accepted and funded, then denied by Delaware 649 Board because I lived in Franklin County.

Consulting Achievements

- ♦ Developed Access & Excel projects which a) tracked 5000+ computers & other significant assets, which b) monitored 2000 800 numbers saving over \$6 million in first month of implementation, which c) balanced millions in credit card transactions for the first time in years.
- ♦ Managed five gigabytes of data monthly and analyzed interest rate risk as part of a team of twenty analysts, maintaining 100% data integrity and creating a tape storage system enabling data recovery within minutes instead of days (or impossible to recover). Each month every account for a \$260 billion national bank passed through my computer.
- ♦ Managed the exit strategy for a nonprofit mental health agency to close its doors, while enabling its 200 clients to be served by an adequately funded program. The original intention was a rescue effort, but financial mismanagement and oversight rules made rescue impossible.
- Organized and processed delinquent IRS notices saving over \$500,000 in tax overpayments and \$100,000+ in penalties and interest by uncovering a box that had been pushed aside.
- ♦ Managed 1099 crisis for large bank. Succeeded in processing and mailing 14,000+ 1099s in two weeks, when the accounts had not been balanced for 3 months. Then cleaned up the approximate 1000 problems left in the wake of the mess.
- Financial Counseling: Helped individuals and small businesses develop plans to acquire homes, finance business expansion and create marketing plans.

- Negotiated non-entry of teamsters union in a bakery distribution company in Youngstown, OH, by enabling the union realize that our drivers were better off on a production based plan than on the union's wage scale.
